Dear Mr Lange,

The Committee on Regional Development, in accordance with Rule 129 of the Rules of Procedure of the European Parliament, held a public confirmation hearing on 12 November 2024 with Raffaele Fitto, the Commission's Executive Vice-President-designate for Cohesion and Reforms, who, subject to the positive outcome of the nomination procedure, will be responsible for Cohesion and Reforms.

On 16 October 2024 the Committee on Regional Development, pursuant to Rule 129 of the Rules of Procedure and Article 2 of Annex VII thereto, received the letter from the Chair of the Committee on Legal Affairs regarding the scrutiny of the declaration of financial interests of Mr Fitto.

Prior to the confirmation hearing, Parliament had sent the Executive Vice-President-designate a list of written questions. My committee took note of the replies provided by Mr Fitto to those questions.

The course of the confirmation hearing is described in the verbatim transcript of the proceedings.

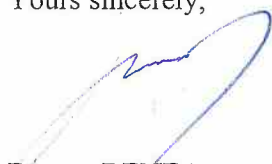
In accordance with Rule 129 of the Rules of Procedure and Article 5 of Annex VII thereto, the REGI coordinators representing a large majority of at least two thirds of committee members belonging to a political group approved that the Executive Vice-President-designate Fitto is qualified both to be a member of the College of Commission and to carry out the specific tasks assigned to him.

The minority opinions of the Greens/EFA group and the Left group are annexed to this letter. In addition, the opinions of the Committee on Transport and Tourism, the Committee on Budgets, the Committee on Agriculture and Rural Development, the Committee on Fisheries, the Committee on Employment and Social Affairs, and the Committee on Economic and Monetary

Affairs, which were invited to participate in the confirmation hearing, are also annexed to this letter.

MINORITY OPINION OF THE VERTS/ALE GROUP

In the hearing that took place on November 12th, commissioner-designate Raffaele Fitto was unfortunately unable to provide a satisfactory reassurance that, contrary to the evidence of his voting record in the European Parliament and public statements, as well as his record as minister for cohesion policy and in charge of the implementation of the Recovery and Resilience Facility, he is fit to be a Commissioner or to be entrusted with ultimate responsibility for Cohesion policy and the RRF, as well as with overseeing agriculture, transport, and fisheries policy. Along with his ambiguous track record on pro-European issues, he also failed to provide a clearly discernible strategy for the future of economic, social, and territorial cohesion of the European Union. Additionally, his lack of commitment to the Green Deal and the climate neutrality targets, as well as his unconvincing responses on his votes on rule of law make it impossible to support him as Executive Vice-President of the European Commission.

MINORITY OPINION OF THE LEFT GROUP

The Left believes that Raffaele Fitto was not able to ensure strong commitments for the social and environmental aspects of the cohesion policy, the importance of the partnership with local and regional authorities and the link with rule of law and fundamental rights. Nor did he give reassuring answers on the worrying link between cohesion and reforms of the European semester, or on his past activities on the implementation of RRF. The Left has also strong concerns on Raffaele Fitto's national party and government, notably their policy on rule of law, RRF or migration.

Furthermore the left strongly denounces the whole process of the Commissioners' evaluations which appeared to be a farce organised by the big groups and strongly weakened the European Parliament role within the E.U.

MINORITY VIEW OF THE S&D AND RENEW EUROPE GROUPS

The S&D and Renew Europe groups regret Ursula von der Leyen's choice to provide Raffaele Fitto with the position of Executive Vice-President. The groups expect him to be fully independent from his national government as required by the Treaties and fully committed to apply the rule of law conditionality mechanism and to work on the strengthening of the rule of law in the Union.
